Wednesday, July 12, 2023 Regular Meeting

The Tilden Township Board of Supervisors met in the Township Municipal Building with the following present: Supervisors Gene Schappell, Fred Herman and Richard Delong, Township Police Chief William McEllroy, Township Solicitor Joan London, Township Road Master Michael Quick, Township Manager/Secretary/Treasurer Monica Flower, Assistant Secretary Samantha Hartman and local residents. A copy of the roster is on file with the secretary.

The meeting was called to order by Chairman Gene Schappell at 7:09 P. M. followed by the Pledge of Allegiance.

# AN EXECUTIVE SESSION WAS HELD ON THURSDAY, JULY 6, 2023 AT 10:30 A.M. AND WEDNESDAY, JULY 12, 2023 AT 6:00 P.M. IN REGARDS TO PERSONNEL.

A Motion was made by Fred Herman and seconded by Richard Delong to amend the agenda to include LeadCar Honda Time Extension Request. Upon roll call Schappell, Herman and DeLong voted yes.

## PUBLIC PARTICIPATION:

- Tammy Berk expressed concerns with all the recent rain, she feels that on some of the roads the shoulders need to be graded to prevent future damage to the roads. Tammy also expressed concerns with the flooding on Industrial Drive which required closing of the road and requests the appropriate work be done to fix the issue and prevent future flooding. The Road Master, Mike Quick addressed her concerns. He noted the continuous work the Road Crew does and emphasized the flooding was primarily due to an abundance of rainfall in the short period of time. Supervisor, Richard Delong commented more work should have been done to prevent the amount of flooding that occurred and requested for Mike to speak with Perry Township Road Crew as they have the equipment needed do perform the work our roads need.

## PUBLIC PARTICIPATION CONCERNING THE INTERSECTION OF LAUREL AVENUE AND PINE ROAD:

- Russ Werley asked for an update on Laurel Avenue being closed. Township Solicitor, Joan London, reviewed the Second Class Township Code which states if there is in the opinion of the Board of Supervisors an unsafe condition, any road or intersection can be closed until the matter is resolved. She then reviewed how a sight distance issue was brought to the attention of the Board, which resulted in the decision of closing the intersection until it is deemed safe again. Joan London mentioned she has spoken to the property owners and a solution is to be found soon. Russ asked about the existing easement in place, in which Joan reviewed the purpose of the easement and its wording.
- Phil Werley states he has a field to get into and the barriers are in the way. The barriers are also in the way of the transportation of a combine tractor. Phil was advised to call Mike Quick at the time the barriers need to be moved so the passage of the tractor can be made successful.
- Kenny Senft requested that the Township Road Crew stop dumping tree stumps and miscellaneous debris on his property. There was a previous verbal agreement allowing this. Mike Quick clarified with the Supervisors there was a previous verbal agreement allowing the Road Crew to do this. Mike recalls about a year or two Kenny approached him to request the end of this. Since then, all debris that was placed on Kenny's property have been removed and the Road Crew no longer dumps on his property.

- Dale Stoudt requested to know how many accidents have occurred at the Pine Road and Laurel Avenue. This data would need to be pulled from the database to answer accurately.
- Russ Werley asked what is being done regarding the traffic concerns at Pine Road and Laurel Avenue and at Pine Road and Mountain Road. Police Chief McEllroy addressed these concerns and requested formal complaints and concerns be called in, as there have not been any calls regarding these concerns. All information regarding traffic concerns was noted by Chief to allow for follow up.
