Saturday, October 3, 2009 Regular Meeting

The Tilden Township Board of Supervisors met in the Township Municipal Building with the following present: Supervisors, Russell Werley, Judy Romig and Troy Hatt, Township Secretary, Cheryl Haus, Township Solicitor, James Lillis and several residents. A copy of the roster is on file with the secretary.

The meeting was called to order by Chairman Russell Werley, at 8:08 A.M. followed by the pledge of allegiance.

Chairman Russ Werley announced that an Executive Session was held on Thursday, October 1 & Saturday October 3, 2009, before the meeting, regarding personnel.

PUBLIC PARTICIPATION - Barry Keller requested exoneration from the Board for a second sewer hook-up for his property @ 107-109 Diamond Drive, which is currently rented. The Board stated if there are two residences, two hook-ups and two quarterly payments will be required.

Walter Axsmith and Rick Boyd of the Northern Berks Recreation Committee asked the Board for an elected Representative to attend a meeting with DCNR regarding local recreation.

A motion was made by Troy Hatt and seconded by Russ Werley to appoint Judy Romig as the elected Tilden Representative to the Northern Berks Recreation Committee. Upon roll call, Hatt, Werley and Romig voted yes.

A letter was sent to PennDOT regarding the manhole situation on West State Street, requesting a meeting to discuss this situation.

REPORT - DRIVEWAY/ROADMASTER

Report for September, 2009 was received.

Five applicants were interviewed for the Road master position.

A motion was made by Russ Werley and seconded by Troy Hatt to hire Tim Luckenbill, as Full-Time Roadmaster, effective immediately, with a six month probation period, with a starting salary of \$14.00, evaluations of 1 month, 3 months and 6 months, with increases of 3%, 4%, 5%, respectively. Upon roll call, Werley, Hatt and Romig voted yes.

REPORT-SECRETARY

The secretary's report for September, 2009 was given by Cheryl Haus. The Berks E.I.T. payment for June 1 to August 31, 2009 in the amount of \$76,260.22 was received. The proposed budget was prepared. The DEP 904 Recycling Grant for 2008 was completed and sent in.

A motion was made by Judy Romig and seconded by Troy Hatt to approve interfund transfers for overbudgeted items. From account number 438.00 apply \$250.00 to 427.14, \$10,000.00 to 429.30, \$2,500.00 to # 430.30, \$3,750.00 to 433.000, \$3,750.00 to 436.000, \$5,000.00 to 437.000. Upon roll call, Romig, Hatt and Werley voted yes.
