### PUBLIC PARTICIPATION:

- Fred Herman, on behalf of the Blue Mountain Wildlife, would like to note the appreciation for the support from Tilden Township, Road Crew, and Police Department.

- Chelsea Williams, the Director of the Hamburg Public Library, thanks the Board for the support and provided a review with updates on the library's goals.
- Susie Bigelow read Article 1 Section 27 of the Bill of Rights. Then stated her concern for her well water being at risk.
- Theodore Driesbach, from Chapter 131 Vietnam Veterans of America, presented his request that the Township begin flying a POW/MIA flag. Stated he will provide the Township with the flag. All Theodore asked for in return is the Township fly this flag in the correct manor.

A Motion was made by Fred Herman and seconded by Richard Delong for the Township to begin flying the POW/MIA flag. Upon roll call Schappell, Herman, and DeLong voted yes.

- Rebekah Barlup reviewed her family's health concerns since moving into Tilden Township, then shares her belief on the connection of the farming practices in the area to her family's health concerns. Rebekah also shared safety concerns for her family in relation to a neighboring property with 15-20 people being housed in a single-family home.
- Gary Weiss expressed his concern with piping that was recently done to cross Old 22 to discharge liquid to farm fields. He states this large amount of liquid in question is spraying approximately 130 feet from his patio.
- Paul Correll expresses concerns of 3 new wells drilled too close to Mill Creek. Also claims the piping that crosses Old 22, previous mentioned, is spraying duck waste from mass duck processing. Paul also provided photos of his concerns that buildings are going up without proper permits.
- Nancy Brickey stated complaints of odor when the wastewater in question is being sprayed.
- Troy Fisher asked for follow up from a previous meeting when it was asked if slaughtering was allowed as a primary use. The answer to this is yes. However, there is no quantity regulation by the Township. Troy also asked if a farmer's total property ownership is considered or if it is just the land usable for spreading that is considered if/when a limit to the amount of waste is spread. Township Solicitor, Joan London is to look into if the state has limits on quantity.
- Bonnie Bailey stated 3 of 5 residential wells that have been tested have failed. She has also contacted the Delaware River Basin Commission with questions relating to wells in the Delaware River Basin.
- Alex Martinez requested to know the difference between agriculture vs intensive agriculture. Township Solicitor, Joan London explained this.

All residents with environmental concerns were advised to file individual complaints to the Department of Environmental Protection. There is an online complaint form and a phone number to file these complaints with the DEP.

- Tyler Hard reviewed his appeal to the Zoning Hearing Board to request the Board's recommendation.

A Motion was made by Gene Schappell and seconded by Fred Herman to provide Zoning Hearing Board with a letter supporting the approval of the special exception requested by Kristy & Tyler Hard @ 2637 Mountain Road. Upon roll call Schappell, Herman, and DeLong voted yes.
