SUBDIVISION/LAND DEVELOPMENT:

A Motion was made by Gene Schappell and seconded by Richard DeLong to approve the original Wawa Preliminary/Final Plans submitted without access reconstruction. Upon roll call, Schappell, Herman and DeLong voted yes.

REPORT - POLICE:

- -The report for August 2019 was given by Chief McEllroy.
- -Chief reported DEP informed the Township one of the planned improvements for the wetlands is to resurface Kernsville Dam Road for emergency vehicle access. They are now stripping that out, DEP sees no need to resurface since DCNR is planning to reopen a couple years from now and allow the area to regrow to its natural state. The Kernsville Dam removal is now scheduled for 2022 due to significant delays. More information should be available by the next meeting.
- -Chief inquired the status of Dave's Way, the Solicitor indicated she has spoken with one of three the property owners involved. They will be working with other property owners to replace signs and paint lines/arrows on the road. The Solicitor will be looking into the timeline of completion.

REPORT - SOLICITOR:

A Motion was made by Fred Herman and seconded by Gene Schappell to adopt Resolution #10-2019 amending Ordinance #64-1987, Section 1, to increase the compensation of each member of the Board of Supervisors whose appointment or term commences o or after December 31, 2019 from \$125.00 to \$155.00 per month. Upon roll call Schappell and Herman voted yes; DeLong voted no.

A Motion was made by Richard DeLong and seconded by Fred Herman to authorize Kozloff Stoudt to advertise the Ordinance and Intergovernmental Agreement with Windsor Township. Upon roll call Schappell, Herman and DeLong voted yes.

A Motion was made by Fred Herman and seconded by Gene Schappell to approve Kozloff Stoudt to advertise the ordinance for the Intergovernmental Cooperation Agreement among the Hamburg School District Municipalities in the implementation of the Northern Berks Joint Comprehensive Plan. Upon roll call Schappell, Herman and DeLong voted yes.

SUBDIVISION/LAND DEVELOPMENT:

-Steven Skoloda presented an update for Walnut Acres. DEP denied their permit request. They have filed an appeal. There is no date for the appeal yet. Mr. Skoloda requested a six month time extension to allow for the appeal process.

A Motion was made by Gene Schappell and seconded by Fred Herman to grant a plan extension of no more than six months to expire on April 15, 2020. Upon roll call Schappell, Herman and DeLong voted yes.
