## ORDINANCE NO. 254-2024

AN ORDINANCE OF TILDEN TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 211, 2012 ESTABLISHING RULES AND REGULATIONS FOR ALL PARKS, PLAYGROUNDS, AND OTHER OUTDOOR RECREATION AREAS TO AMEND SECTION I, PARAGRAPH 1 TO CHANGE THE HOURS OF OPERATION OF SENATOR JAMES RHOADES MEMORIAL PARK TO 7:00 A.M. TO 10:00 P.M. PREVAILING TIME, WITH ALL OTHER PORTIONS OF ORDINANCE NO. 211, 2012 TO REMAIN IN FULL FORCE AND EFFECT

IT IS HEREBY ENACTED AND ORDAINED by the Board of Supervisors of Tilden Township, Berks County, Pennsylvania, as follows:

**Section 1. Amendment to Park Hours**. Section I, Paragraph 1, shall be amended to read as follows:

1. All Parks shall be open from 7:00 a.m. to 9:00 p.m. daily, with the exception of Senator James Rhoades Memorial Park, which shall be open from 7:00 a.m. to 10:00 p.m. daily. Overnight or off-hour activities will be allowed upon proper application to the Township Manager or his or her designee.

<u>Section 2</u>. <u>Full Force and Effect of Remaining Ordinances</u>. The Ordinances of Tilden Township, Berks County, Pennsylvania, shall be and remain unchanged and in full force and effect except as amended, supplemented or modified by this Ordinance. This Ordinance shall become a part of the Ordinances of Tilden Township, Berks County, Pennsylvania, upon adoption.

<u>Section 3</u>. <u>Severability</u>. If any sentence, clause, section, or part of this ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, legality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this ordinance. It is hereby declared as the intent of the Township Board of Supervisors that this ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.

<u>Section 4. Repealer.</u> All ordinances or parts of ordinances of the Township which are inconsistent herewith are hereby repealed.

<u>Section 5</u>. <u>Effective Date</u> This Ordinance shall become effective on the earliest date permitted by law.
