- PC Members reviewed pages 100-168. Slight changes were made and many grammatical errors were addressed.
- Section 4080: Ag- Tourism
 - o (A)-PC members would like a written agreement to be required.
 - o (E)- An emergency plan must be provided to BOS
- Section 4092: Restaurant
 - o (A)- no signs should be zip tied or secured by other temporary means
- Section 4120: Logistic Centers
 - o (N) Colors- PC would like this whole definition changed.
- Section 4121: Self Storage Facility
 - o (A) PC Members suggested this be removed
 - o (C) No storage outside of goods or vehicles shall be permitted.
- Section 4138: Recreation, Outdoor
 - o (2) Application
 - Emergency contact info should be provided for all applicants at campgrounds
 - o (11) Regulation for storage and Use of Recreational Vehicles
 - (i) & (ii) must be revised. PC members do not want these sections removed but revised.
- Section 4150: Dwelling, Multi Family
 - o (a) can be removed
 - o (b) PC members would like trash and recycling to be added to this definition
 - (e) PC would like to add another letter *e* which would be a plan for a common area, pedestrian circulation and handicap parking. This plan must be approved by BOS
- Section 4156: Mobile Home Park
 - Removing all letters except (K)
- PC members would like to combine Section 4155 and 4157.
- Section 5001: Required off street parking spaces
 - o PC Members would like to add something about pedestrian movements / walkways
- Section 5003: Area and Design Standards and other requirements relating to parking and loading spaces
 - o (J) Landscaping Plan
 - Would like to add another bullet point with a note about replacing dead plants

A Motion was made by Dale Keener and seconded by Luke Kamp to cancel the February 4th meeting. Upon role call Keener, Kozlowski, and Kamp voted yes.
