ORDINANCE

AN ORDINANCE OF THE TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA OPENING AS PUBLIC TOWNSHIP ROADS FOR PUBLIC USE AND TRAVEL:

RUTH STREET FROM YODER STREET TO KATHRYN STREET,  
MARION STREET FROM YODER STREET TO KATHRYN STREET,  
HAZEL STREET FROM YODER STREET TO A 12 FT. WIDE ALLEY,  
CARL STREET FROM HAZEL STREET TO CLAYTON AVENUE,  
KATHRYN STREET FROM CLAYTON AVENUE TO RUTH STREET  
YODER STREET FROM THE NORTH SIDE OF RUTH STREET SOUTH-  
WARDLY TO A POINT 150 FT. SOUTH OF THE SOUTHERLY SIDE  
OF HAZEL STREET,  
SAID STREETS BEING LOCATED IN THE AREA OF TILDEN TOWN-  
SHIP KNOWN AS "YODER HEIGHTS" AND SHOWN ON THE PLAN OF  
"YODER HEIGHTS"

BE IT ENACTED AND ORDAINED by the Supervisors of  
Tilden Township, Berks County, Pennsylvania, AND IT IS  
HEREBY ENACTED AND ORDAINED by the authority of the same  
as follows:

SECTION 1 - That RUTH STREET in the Plan of  
Yoder Heights from the easterly side of Yoder Street  
eastwardly for a distance of 1331.6 feet to the  
westerly side of Kathryn Street, be opened as a  
public Township road to a width of 40 feet.

SECTION 2 - That MARION STREET in the Plan of  
Yoder Heights from the easterly side of Yoder  
Street eastwardly for a distance of 1128.05 feet  
to the westerly side of Kathryn Street be opened as  
a public Township road to a width of 40 feet.

SECTION 3 - That Hazel Street in the Plan of Yoder Heights from the easterly side of Yoder Street eastwardly for a distance of 925.53 feet to the eastwardly side of a 12 feet wide alley adjoining property of now or late Ray Grimm, be opened as a public Township Road to a width of 40 feet.

SECTION 4 - That Carl Street in the Plan of Yoder Heights from the northerly side of Hazel Street northwardly for a distance of 423.82 feet to the southerly side of Clayton Avenue, which is Township Route 699. be opened as a public Township road to a width of 40 feet.

SECTION 5 - That Kathryn Street in the Plan of Yoder Heights beginning at the north side of Clayton Avenue, which is Township Route 699, northwardly, a distance of 724.98 feet to the northerly side of Ruth Street, be opened as a public Township road to a width of 40 feet.

SECTION 6 - That Yoder Street in the Plan of Yoder Heights from the northern side of Ruth Street southwardly for a distance of 1388.11 feet to a point 150 feet south of the southerly side of Hazel Street, be opened as a public Township road to a width of 40 feet.

SECTION 7 - That a Plan of Yoder Heights showing the aforesaid streets described and set forth in

Sections 1 to 6 inclusive of this Ordinance, be attached hereto, made a part hereof, and be on file at the office of the Secretary of the Board of Supervisors of Tilden Township.

SECTION 8 - The Secretary and the Township Solicitor be and they are hereby authorized to perform and do on behalf of the Township all acts, matters and things requisite and necessary to cause this Ordinance to be in full force and effect.

SECTION 9 - All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed.
