

AN ORDINANCE PROVIDING FOR THE LEVY, ASSESSMENT AND COLLECTION OF A PER CAPITA TAX, FOR GENERAL TOWNSHIP PURPOSES, ON EACH AND EVERY RESIDENT AND INHABITANT OF THE TOWNSHIP OF TILDEN OVER TWENTY-ONE (21) YEARS OF AGE; PROVIDING FOR THE COLLECTION OF SUCH TAX, AND IMPOSING PENALTIES.

The Supervisors of Tilden Township hereby enact and ordain as follows:

SECTION 1 - A per capita tax of FIVE DOLLARS (\$5.00), for general Township purposes, is hereby levied and assessed under the authority of the Act of the General Assembly of Pennsylvania, approved December 31, 1965, P.L. 511, known as The Local Tax Enabling Act, upon each resident or inhabitant of the Township of Tilden over the age of twenty-one (21) years, which tax shall be in addition to all other taxes levied and assessed by the said Township.

SECTION 2 - Such tax shall be collected by the duly elected or appointed Tax Collector of the Township of Tilden in the same manner and at the same time as other Township taxes are collected, as provided by the Local Tax Collection Law of 1945, as amended and supplemented.

SECTION 3 - The expense of collection and compensation of the Tax Collector shall be paid and allowed as provided in the Local Tax Collection Law of 1945 as amended and supplemented, which compensation shall be the same as shall be fixed from time to time for the collection of Township real property taxes.

SECTION 4 - The Tax Collector shall demand, receive and collect the tax provided for herein from all individuals liable for the payment of the same, and in so doing shall have

all of the powers conferred upon him by the  
Assembly of Pennsylvania, No. 511, approved December 31, 1965,  
known as The Local Tax Enabling Act. The Tax Collector shall  
allow discounts from and add penalties to the amount of tax  
owing, and shall remit such taxes and penalties to the Township  
Treasurer by separate statement at the same time as other taxes  
are remitted to the Township, as provided by The Local Tax  
Collection Law of 1945, as amended and supplemented.

SECTION 5 - Provisions of this Ordinance shall become  
effective on the first day of January, 1968, and shall continue  
in effect for the remainder of the calendar year 1968 and from  
year to year thereafter without annual re-enactment until altered,  
amended, or rescinded by appropriate action of the Board of  
Supervisors of the Township of Tilden.

SECTION 6 - If any sentence, clause, section or part  
of this Ordinance is for any reason found to be unconstitutional,  
illegal or invalid, such unconstitutionality, illegality or inva-  
lidity shall not affect or impair any of the remaining provisions  
of this Ordinance. It is hereby declared as the intent of the  
Board of Supervisors that this Ordinance would have been adopted  
had such unconstitutional, illegal or invalid sentence, clause,  
section or part thereof not been included herein.
