AN ORDINANCE OF THE TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA AMENDING ORDINANCE NO. 63 OF 1987, AS AMENDED, REGULATING TRAFFIC AND PARKING IN THE TOWNSHIP: TO ESTABLISH STOP INTERSECTIONS (1) TRAVELING SOUTH ON FISHER DAM ROAD AT THE INTERSECTION OF THE GRADE CROSSING OF THE READING BLUE MOUNTAIN & NORTHERN RAILROAD AND (2) TRAVELING NORTH ON FISHER DAM ROAD AT THE INTERSECTION OF THE GRADE CROSSING OF THE READING BLUE MOUNTAIN & NORTHERN TO ESTABLISH NO AND RAILROAD REGULATIONS ON THE UNNAMED ROAD BETWEEN INDUSTRIAL DRIVE AND THE TOWNSHIP'S PUMPING STATION

WHEREAS, the Township of Tilden, Berks County, Pennsylvania (the "Township") adopted Ordinance No. 63 of 1987, as amended by Ordinance Nos. 65-1988, 69-1988, 87-1991, 92-1993, 93-1993, 98-1993, 102-1994, 106-1995, 109-1996, 116-1997, 124-1999, 126-1999, 127-2000, 135-2001, 136-2001 and 137-2001, regulating traffic and parking in the Township (collectively, the "Traffic and Parking Ordinance"); and

WHEREAS, the Township now desires to amend the Traffic and Parking Ordinance by (1) amending Article II, Section 3 pertaining to stop intersections and (2) amending Article III, Section 1 pertaining to no parking.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Tilden, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

<u>Section 1</u>. Section 3, entitled "Stop Intersections Established", of Article II, entitled "Traffic Regulations", of the Traffic and Parking Ordinance is hereby amended in its entirety so as to hereafter read as follows:

"Section 3. Stop Intersections Established.

(a) The following intersections are established as stop intersections, and official stop signs shall be erected, or are ratified if previously erected, in such a position as to face traffic approaching the second-named street (the through street) on the first-named street (the stop street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first-named or stop street, in the direction indicated in

each case, shall stop the vehicle as required by the Pennsylvania Vehicle Code, 75 Pa. C.S. Section 3323(b), and shall not proceed into or across the second-named or intersecting or through street until he has followed all applicable requirements of that section of the Code.

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of Twenty-Five Dollars (\$25.00) and costs."

Section 2. Section 1, entitled "Parking, Stopping and Standing Prohibited at All Times in Certain Locations", of Article III, entitled "Parking Regulations", of the Traffic and Parking Ordinance is hereby amended in its entirety so as to hereafter read as follows:

"Section 1. Parking, Stopping and Standing Prohibited at All Times in Certain Locations. Parking, stopping and standing shall be prohibited at all times in the following locations:

Jetson Drive	North and South	Intersection of Jetson Drive and Industrial Drive to intersection of Jetson Drive and S.R. 61
Moonlight Drive	North and South	Intersection of Moonlight Drive and Clayton Avenue to the intersection of Moonlight Drive and Sunrise Drive
Pine Road	North	Intersection of Pine Road and Clayton Avenue
West State Street	South	Intersection of the centerline of Hill Drive and West State Street to a point 175 feet westwardly thereof
Unnamed Road	All	Intersection of unnamed road and Industrial Drive (T-571) to the Tilden Township Pumping Station"

Section 3. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of Tilden Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

<u>Section 4</u>. All prior ordinances of the Township of Tilden, insofar as they deal with the regulation herein are repealed and declared unenforceable insofar as they are inconsistent with or identical to any provision of this Ordinance.

Section 5. This Ordinance shall take effe	ect five (5) days after its enactment.
