

ORDINANCE NO. 179,2007

AN ORDINANCE OF THE TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA AMENDING SECTION 301, ENTITLED "PARKING, STOPPING AND STANDING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS", OF PART 3, ENTITLED "PARKING REGULATIONS", OF CHAPTER XIX, ENTITLED "MOTOR VEHICLES AND TRAFFIC", OF THE CODE OF ORDINANCE OF THE TOWNSHIP OF TILDEN TO PROHIBIT PARKING, STOPPING AND STANDING ON THE NORTH SIDE OF THE INTERSECTION OF WEST STATE STREET AND DIAMOND DRIVE A DISTANCE OF 100 FEET EAST

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Tilden, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

SECTION 1. Section 301, entitled "Parking, Stopping and Standing Prohibited at All Times in Certain Location", of Part 3, entitled "Parking Regulations", of Chapter XIX, entitled "Motor Vehicles and Traffic", of the Code of Ordinances of the Township of Tilden is hereby amended and restated in its entirety so as to hereafter read as follows:

"Section 301. Parking, Stopping and Standing Prohibited at All Times in Certain Locations. Parking, stopping and standing shall be prohibited at all times in the following locations:

<u>Street</u>	<u>Side</u>	<u>Between</u>
Berne Road	North	Intersection of Fisher Dam Road (T-558) and Berne Road (T-811) to a point northwardly thereof
Industrial Drive	East and West	Industrial Drive, West of the railroad crossing to and including the cul-de-sac on Industrial Drive (located in the Tilden Industrial Park)
Jetson Drive	North and South	Intersection of Jetson Drive and Industrial Drive to intersection of Jetson Drive and S.R. 61

Moonlight Drive	North and South	Intersection of Jetson Drive and Clayton Avenue to the intersection of Moonlight Drive and Sunrise Drive
Pine Road	North	Intersection of Pine Road and Clayton Avenue
West State Street	North	Intersection of the centerline of Diamond Drive and West State Street to a point 50 feet westwardly thereof
	North	Intersection of the centerline of Diamond Drive and West State Street to a point 100 feet eastwardly thereof
	North	Intersection of the centerline of Maple Drive and West State Street to a point 80 feet eastwardly thereof
	South	Intersection of the centerline of Hill Drive and West State Street to a point 175 feet westwardly thereof
Unnamed Road	All	Intersection of unnamed road and Industrial Drive (T-571) to the Tilden Township Pumping Station"

SECTION 2. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of the Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 3. All ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

SECTION 4. This Ordinance shall become effective in accordance with law.

SECTION 5. The Code of Ordinances of the Township of Tilden, Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented and modified by this Ordinance. This Ordinance shall become a part of the code of Ordinances of the Township of Tilden, Berks County, Pennsylvania, as amended, upon adoption.
