ORDINANCE NO. 47, 1980

AN ORDINANCE OF THE TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA, ESTABLISHING A SPEED LIMIT OF 25 MILES PER HOUR ON HILL ROAD WITHIN THE TOWNSHIP OF TILDEN AND ESTABLISHING A PENALTY FOR THE VIOLATION OF SUCH SPEED LIMIT

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Tilden, Berks County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by authority of the same, as follows:

SECTION 1. Definitions and Interpretations. Words and phrases when used in this Ordinance shall have the meanings ascribed to them in the Vehicle Code of Pennsylvania as now are in force or as are hereinafter amended and enacted or re-enacted, except in those instances where the context clearly indicates a different meaning. The singular shall include the plural and the masculine shall include the feminine.

SECTION 2. Permanency. The traffic regulations established herein shall be of a permanent nature and shall be enacted and considered as an amendment or addition to other traffic ordinances of the Township of Tilden.

SECTION 3. Speed limit established. A speed limit of twenty five (25) miles per hour is hereby established for that section of Hill Road in the Township of Tilden, Berks County, Pennsylvania, between the intersection of Hill Road and West State Street in West Hamburg, Tilden Township, Berks County, Pennsylvania, to intersection of Ash Road. The aforesaid speed limit shall be properly posted in accordance with the Motor

Vehicle Code of the Commonwealth of Pennsylvania as enacted and amended.

All operators of motor vehicles making use of such road between the aforesaid points and within the prescribed mile per hour speed zone shall not operate such motor vehicles in excess of said speed limit.

SECTION 4. Penalty for violation. Any person who shall violate any of the provisions of this Section shall, upon conviction thereof, be sentenced to pay a fine in accordance with fines prescribed for violating a posted speed limit area in accordance with the Motor Vehicle Code of the Commonwealth of Pennsylvania and, in default of payment of such fine and costs, to imprisonment in the county jail for not more than five (5) days.

SECTION 5. Severability. The provisions of this Ordinance shall be severable; and if any of its provisions shall be held to be unconstitutional or illegal, such decisions shall not affect the validity of any remaining provisions of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been adopted if such unconstitutional or illegal provision had not been included.

 $\underline{\text{SECTION}}$ 6. Repealer. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
